OVERVIEW

Andrew von Dadelszen is a Justice of the Peace for New Zealand, and his academic training includes being qualified with an MBA from Henley Management College & Brunel University, London.

Andrew has held diverse governance and leadership roles in business, the public and not-for-profit sectors. He has completed the Institute of Directors 5 Day Course, and is a current Director on the Board of the Crown Research Institute – Plant & Food Research (2014 – current - reappointed to 2020). Andrew has previously been a Board Director of the Environmental Protection Authority – a Crown Agency; and also spent three years as a director of the NZX listed Quayside Holdings. For six years (2004 to 2010) he was an elected Bay of Plenty Regional Councillor, chairing the Transport Committee. In October 2016 Andrew was re-elected to the Bay of Plenty Regional Council.

Andrew has a clear understanding of the role of governance and the complexities of grappling with strategic and public policy issues. His strengths include strong financial and analytical literacy gained from both practical business delivery and academic training.

Andrew is also a qualified Resource Management Consent Hearings Commissioner with a current Chairs Endorsement, and his track record in resolving complex RMA issues is on public record. He has also been a Tauranga City Council appointed Commissioner on the District Licensing Committee. Andrew has been professionally employed in the Not-for-Profit Sector to act as a mediator in matters requiring dispute resolution, as well as a consultant and facilitator for completing organisational strategic reviews.

Andrew's diverse professional background - including central & local government corporate governance, finance & investment advice, farming, service industries and the not-for-profit sector - means he has a very broad base of experience. He has an extensive background in large scale farming operations, and operated his own sharebroking business for 17 years. Andrew understands both rural and urban issues, and would bring a sound balanced profile to this position. Andrew has lived and worked closely with Tāngata Whenua, appreciating their cultural diversity, as well as the relevance of our Treaty of Waitangi responsibilities. He spent 17 weeks learning Te Reo Maori at the local Wananga.

Andrew has been a government appointee to the Committees of both the Lotteries Community Facilities Fund and the Lotteries Significant Projects Fund; distributing in excess of \$47m in the 2015 year. He has also been a past member of Local Government New Zealand's (LGNZ) Transport Reference Group.

Andrew was a judge of the Tauranga Chamber of Commerce Business Awards for 6 years, and the Bay of Plenty Sustainable Business Network Awards for 2 years.

Andrew has been actively involved with international environmental issues particularly through the NGO, The Advisory Committee on the Protection of the Sea (ACOPS), a UK registered charity, based out of Cambridge in the United Kingdom. ACOPS was set up by Lord Callaghan, a former British Prime Minister, and its aim is to work with governments to promote marine-based environmental protection. Andrew was a member from 1994, and between 2002 and 2014 was both a Trustee to the Charity and a Director, undertaking the role as Honorary Treasurer. Andrew's work for ACOPS has seen him hone his diplomacy skills while working with many of the world's leading politicians. ACOPS projects have included substantive initiatives in the Russian Arctic, Sub-Saharan Africa, Libya, the Caribbean and South East Asia.

At a local level Andrew spent three years (2005 to 2008) as President of the Tauranga Club (with over 600 members). He is an active member of Rotary, first joining in 1994, and was President of Tauranga Te Papa Rotary Club for the 2015-16 year. He currently chairs the Tauranga Rotary Centennial Trust for the Kopurererua Valley Reserve Development, and was Treasurer for the 2017 Rotary District 9930 Annual Conference. He also chaired the 2014, 2016 and 2017 Tauranga City Air Shows. Andrew was awarded a Paul Harris Fellowship in recognition of his commitment to both Rotary and his local community.

Andrew is also a current Board member and Treasurer of Not-for-Profit charity – Te Aranui Youth Trust, which operates out of the Greerton Police Station and supports vulnerable children. Andrew was previously Deputy Chair and Treasurer of the local NFP Charity - Volunteer Western Bay of Plenty.
